**ARTICLES OF ORGANIZATION  
OF  
MIGDAL OR GROUP LLC**

The undersigned, being a duly authorized representative of the Member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

**ARTICLE I  
NAME**

The name of the limited liability company is Migdal Or Group LLC (the "Company").

**ARTICLE II  
ADDRESS**

The principal and mailing address of the Company is 20900 NE 30<sup>th</sup> Avenue, Suite 309, Aventura, Florida 33180.

**ARTICLE III

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida including activities within the United States and abroad.


**ARTICLE VIII
