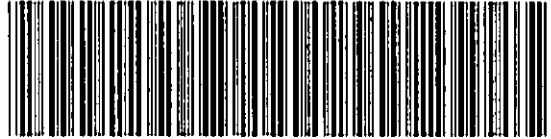

Pursuant to the provisions of Section 605.1025, Florida Statutes, South Lake Complex, LLC, a Florida limited liability company ("South Lake") and Four Corners Eye Partners, LLC, a Florida limited liability company ("Four Corners") adopt the following Articles of Merger for the purpose of merging South Lake into Four Corners.

**ARTICLE I**

ARTICLE VI

The merger is permitted under the laws of the State of Florida and is not prohibited by the Operating Agreements or Articles of Organization of South Lake or Four Corners.



The effective date of the merger shall be the date this document is filed with the Florida Department of State.


