**ARTICLE V – Perpetual Duration**

The period of duration of MPBH, LLC is perpetual.

**ARTICLE VI – Form of Management**

The management of MPBH, LLC shall be vested on the members pursuant to the Operating Agreement.

**ARTICLE VII – Purpose**

The purpose of the company is to engage in any lawful or activity for which an LLC may be organized under the laws of Florida and the United States.

**ARTICLE VIII – Amendment of Articles**

These Articles of Organization shall be amended as follows: every proposed amendment to these Articles of Organization shall require the approval by the Managers, whereupon it shall be proposed to all the Members, and, for adoption, shall require the approval at a Member's meeting by a majority of the Members entitled to vote thereon; alternatively, the Members may sign a written statement adopting the proposed Amendment to these Articles of Organization.

**ARTICLE IX – Operating Agreement**

The Operating Agreement will establish the duties and responsibilities of each authorized member as well as method of distribution of profits and liability for expenses. In the event of conflict between the Operating Agreement and the Articles of Organization, the Operating Agreement will govern.

**ARTICLE X - Right To Continue Business**

In the event of the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in MPBH, LLC, the remaining members have the right under the operating agreement to continue the business of MPBH, LLC.

**ARTICLE XI - Certificate of Membership**

A member's interest in MPBH, LLC, may be evidenced by a certificate of membership interest signed by the Authorized Member of the LLC, which may be assigned or transferred. The right to assign or transfer a member's interest in MPBH, LLC is limited by the provisions of the Operating Agreement.
