ARTICLE IV - MANAGEMENT

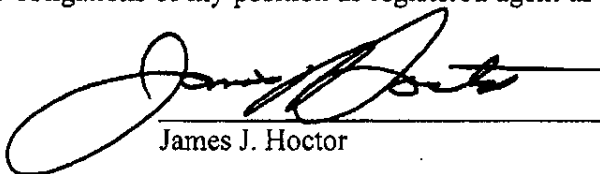
