ARTICLE VI MANAGEMENT

All powers of the Company shall be exercised by or under the authority of the members and, except as otherwise provided in the operating agreement of the company ("Operating Agreement"), the business and affairs of the Company shall be managed by or under the direction of one or more Managers (or Authorized Members).
