**ARTICLES OF ORGANIZATION  
OF

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

**ARTICLE I  
NAME**

The name of the limited liability company is WOLFE ESTATES, LLC (the "Company").

**ARTICLE II  
ADDRESS**

The Company shall be conducted, carried on, and managed by its Member and is, therefore, a Member-Managed Company. The name and address of the Authorized Member is:




