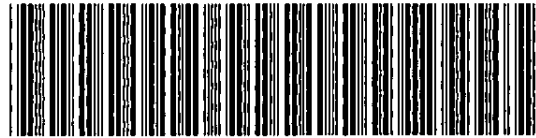

ARTICLES OF ORGANIZATION

OF

KINDRID, LLC

The undersigned, for the purpose of forming a single-member Florida limited liability company under the Florida Revised Limited Liability Company Act, F.S. Chapter 605, (the "Act") hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **KINDRID, LLC** ("company"); provided, however, that the member may, to the extent permitted by the Act, change the name of the company at any time or from time to time and cause the company to do business at the same time under one or more fictitious names if the member deems it is in the best interest of the company.

ARTICLE II -- ADDRESS

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State, Division of Corporations. 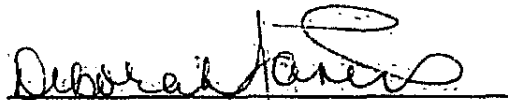

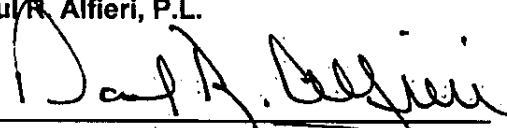
