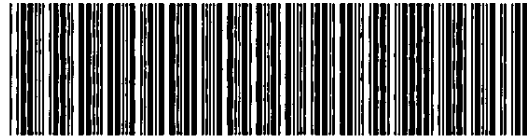




ARTICLE IV
