#### ARTICLES OF ORGANIZATION OF SUFFRAGIUM, LLC

The undersigned organizer, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

## ARTICLE I
