**ARTICLES OF ORGANIZATION  
OF  
ALIEN SHRIMP MUSIC PUBLISHING, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Revised Limited Liability Company Act (Florida Statutes Chapter 605).

**ARTICLE I**

Name: The name of this limited liability company is Alien Shrimp Music Publishing, LLC (the "Company").

**ARTICLE II**

Mailing Address and Street Address: The Company's mailing address and street address of the principal office is 420 Jefferson Avenue, Miami Beach, Florida 33139.

**ARTICLE III**

**ARTICLE IV**

Duration: The Company shall exist from the date of filing these Articles with the Department of State until the occurrence of any of the events specified in Florida Statutes Section 605.0701, unless continued by the unanimous consent of all of the remaining members.
