#### ARTICLES OF ORGANIZATION OF CCM DORAL, LLC

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the Laws of the State of Florida, Chapter 605, Florida Limited Liability Company Act, providing for the information, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

#### ARTICLE I NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be CCM DORAL, LLC and its principal office shall be located at 823 Cypress Blvd., #104, Pompano Beach, FL 33069, County of Broward, State of Florida, and the mailing address shall be the same but it shall have the power and authority to establish branch office at any other places as the members may designate.

- 5. Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.
