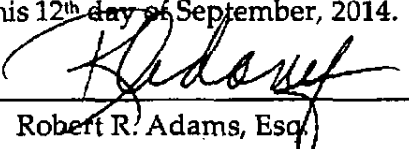
ARTICLE IX -- TERMINATION OF EXISTENCE

ARTICLE X -- INDEMNIFICATION

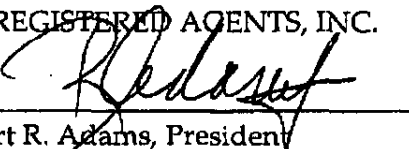
