ARTICLES OF ORGANIZATION
OF
LAUREN ANDREWS DESIGN, LLC

The undersigned person, acting as the organizer of **LAUREN ANDREWS DESIGN, LLC** under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is:
