ARTICLES OF ORGANIZATION OF NORTH AMERICAN SOLAR PROFESSIONALS, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I

The name of the Limited Liability Company shall be NORTH AMERICAN SOLAR PROFESSIONALS, LLC ("Company"). 


