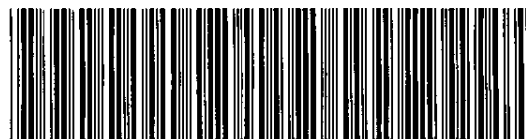

The undersigned, on behalf of the limited liability companies set forth below, pursuant to section 605.1035 of the Florida Statutes, state as follows:

1. The name of the acquired limited liability company is Merlin RAMCo, LLC.
2. The name, jurisdiction of formation, and type of entity of the acquiring entity is TCFI MERLIN LLC, a Delaware limited liability company.
3. The plan of interest exchange was approved by Merlin RAMCo, LLC in accordance with the provisions of sections 605.1031-605.1036 of the Florida Statutes and by each member of Merlin RAMCo, LLC who, as a result of the interest exchange, will have interest holder liability under section 605.1033(1)(b) of the Florida Statutes and whose approval is required.
4. There are no amendments to the Merlin RAMCo, LLC's public organic record to be approved as part of the plan of interest exchange.
5. The plan of interest exchange was approved by TCFI MERLIN LLC, the only acquiring entity that is a party to the interest exchange, in accordance with the organic laws in Delaware, TCFI MERLIN LLC's jurisdiction of formation.
6. TCFI MERLIN LLC has agreed to pay to any members of Merlin RAMCo, LLC with appraisal rights the amount to which such members are entitled under sections 605.1006 and 605.1061-1072 of the Florida Statutes.
