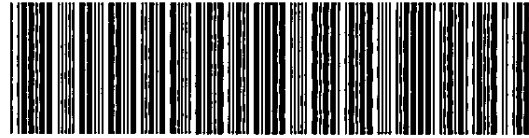

The name of the limited liability company is: Sand Dollar Family Holdings,


