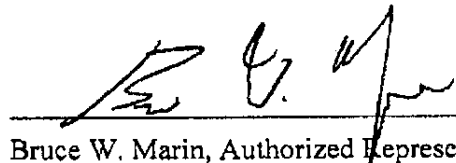
ARTICLE V. MANAGEMENT

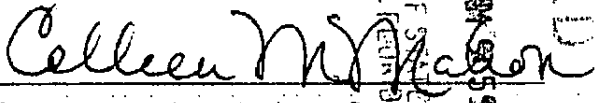
