**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
FOR

Pursuant to the provisions of Chapter 605 of the Florida Statutes, the undersigned has executed and hereby files the following Amended and Restated Articles of Organization for such limited liability company.

The present name of the limited liability company is **HARBOR SAN ANTONIO INVESTMENT, LLC** (the "Company"); the date of filing of its original Articles of Organization with the Florida Secretary of State was September 9, 2014 and assigned Florida document number L14000147629.

ARTICLE I. NAME

ARTICLE II. ADDRESS

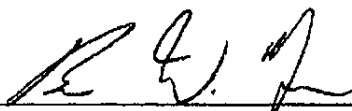
ARTICLE V. MANAGEMENT
