**ARTICLES OF ORGANIZATION

Pursuant to the provisions of Chapter 605 of the Florida Statutes, the undersigned hereby declares the following provisions as the Articles of Organization of ST. PETE SECOND STREET, LLC, a Florida limited liability company (the "Company").

ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Company is ST. PETE SECOND STREET, LLC, and its principal office and mailing address is 100 Second Avenue South, Suite 701, St. Petersburg, FL 33701.

ARTICLE 2: DURATION

This Company shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of the State of Florida.

ARTICLE 3: PURPOSE


ARTICLE 7: MANAGEMENT: INITIAL MEMBERS


