

1. The name of the limited liability company is BEACHFIT STUDIO, LLC (the "LLC").
2. The Articles of Organization of the LLC were filed on September 22, 2014 and assigned document number L14000147873.
3. The dissolution was unanimously approved by the members of the LLC on April 15, 2017.
