**ARTICLES OF ORGANIZATION
OF
BROOME DEVELOPMENT, LLC**

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is Broome Development, LLC (the "Company"). The Company's principal address and mailing address is 2190 Belcher Road South, Suite B, Largo, Florida 33771. 




