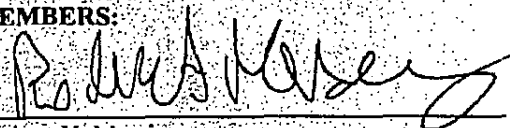
"ARTICLE I"
