Pursuant to the provisions of section 605.707, Florida Statutes, this limited liability company adopts the following Articles of Dissolution to its Articles of Organization:

**FIRST:** The name and address of this Company is OMIBIT LLC, 12 Cardiff Way, Boynton Beach, Florida 33428.

**SECOND:** The Articles of Organization were filed on September 23, 2014 and assigned document number L14000149406.

**THIRD:** The date of the adoption of these Articles of Dissolution is 29 March 2018.

**FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 605.0709. The remaining property and assets have been distributed among its members in accordance with their respective rights and interests. The amendment was unanimously approved in writing by all members.
