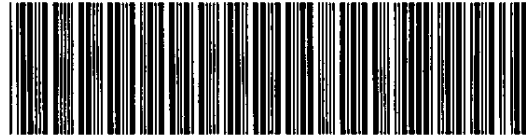

FOURTH: The effective date of this Article of Amendment shall be January 5, 2015.


