**ARTICLES OF DISSOLUTION

- THIRD:** The date of the adoption of these Articles of Dissolution is 12 April 2016.

It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 605.0709.
