The undersigned, Eric Johnson, a natural person competent to contract and a member of Miramar Beach Service, LLC, hereby presents these Articles of Organization as the Articles of Organization of Miramar Beach Service, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Miramar Beach Service, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS
