

ARTICLES OF ORGANIZATION OF REGENCY WEST LAND LEASE, LLC

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State of Florida.

ARTICLE I Name

The name of the limited liability company shall be REGENCY WEST LAND LEASE, LLC.

ARTICLE II Address and Place of Business

The mailing address and principal place of business for the limited liability company is:

ARTICLE III Period of Duration

ARTICLE VI <u>Management</u>

ARTICLE VII Continuity of Business
