**ARTICLES OF ORGANIZATION  
OF

The undersigned, being a duly authorized representative of the Members, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

**ARTICLE I. NAME**

The name of the limited liability company is LER, LLC (the "Company").

**ARTICLE II. ADDRESS**

The principal and mailing address of the Company is 13320 N. Calusa Club Drive, Miami, Florida 33186.

**ARTICLE III. REGISTERED AGENT AND OFFICE**


**ARTICLE IV. DURATION AND CONTINUATION**
