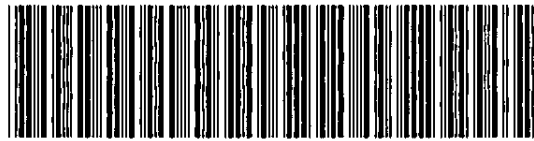

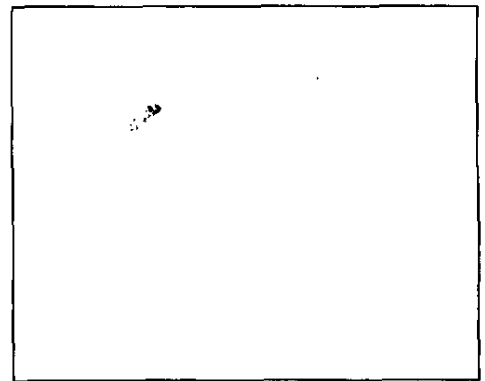

### Operating Agreement

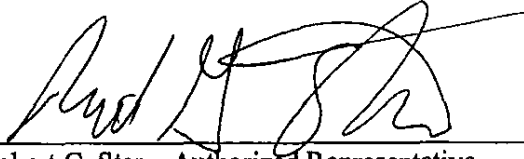
