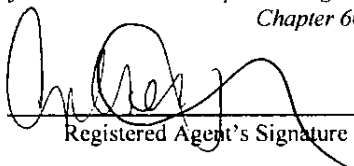

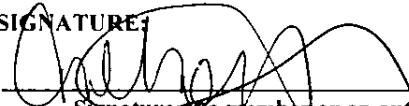

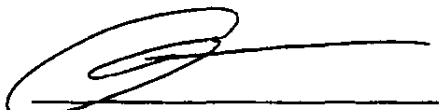
**SPECIAL AND REVOCABLE
