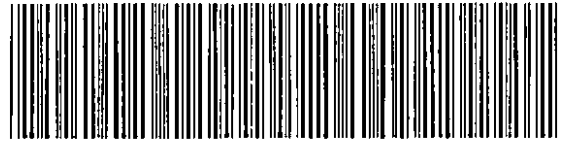

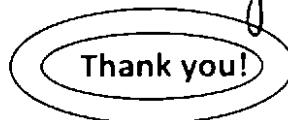

Pursuant to Section 605.1025 of the Florida Revised Limited Liability Company Act, the undersigned entity submits the following Articles of Merger as the surviving business entity in a merger between business entities.
