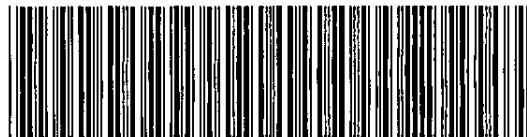


1. Article 5. is deleted in its entirety and the following is inserted in its place and stead:
