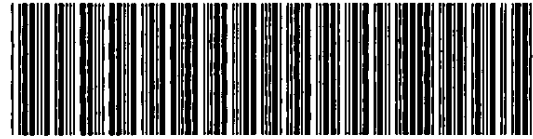

**ARTICLES OF ORGANIZATION

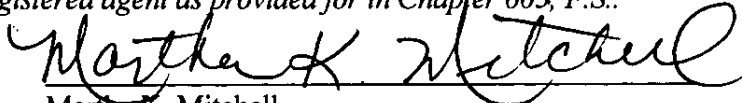

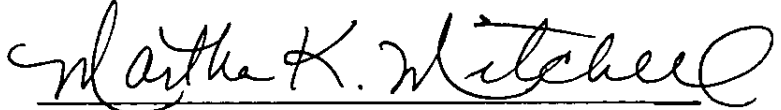

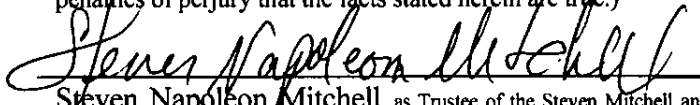
