**ARTICLE I
NAME**

The name of the Company will be: **MIND, BODY & MODERN MEDICINE, LLC.**

**ARTICLE II
ADDRESS AND PLACE OF BUSINESS**

The mailing and street address for the Company's principal office is 8341 Carolyn Drive, Port Richey, Florida 34668.

**ARTICLE III
PERIOD OF DURATION**

The Company will be effective on the date of the filing of these Articles of Organization, and its period of duration Company will be perpetual.

**ARTICLE IV
GENERAL POWERS**

The Company is formed for the purpose of conducting and undertaking, and will have the power to conduct and undertake, any and all activities and actions authorized and permitted under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes.

**ARTICLE V
MANAGEMENT AND OWNERSHIP**

All powers of the Company will be exercised by or under the authority of the members and, except as otherwise provided in the operating agreement of the company ("Operating Agreement"), the business and affairs of the Company will be managed by or under the direction of one or more Managers (or Authorized Members). At all times, a Florida licensed physician will own not less than 1% of the Company. Initially, Danny Abbruzzese, M.D. will own 1% of the Company, and Faith Bevan, MS, PA-C will own 99%.

**ARTICLE VI
RIGHT TO CONTINUE BUSINESS**

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of member in the Company, the business of the Company will not cease and the Company will not cease and the Company will not be dissolved except by the unanimous consent of the remaining members or as otherwise provided in the Operating Agreement of the Company.

The Company may change its registered agent or its registered office or both by filing with the Department of State of the State of Florida a statement complying with Section 605.0113, Florida Statutes.
