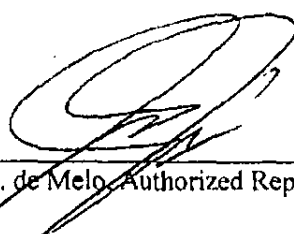
ARTICLE IV
