ARTICLES OF ORGANIZATION OF BASIS WHOLE BODY WELLNESS, LLC.

The undersigned, desiring to form a limited liability company under the provisions of the laws of the State of Florida, do hereby make, subscribe and acknowledge before a notary public, and file with the Secretary of State of the State of Florida, the following Articles of Organization for such limited liability company:

ARTICLE I - NAME

The name of the corporation is:

BASIS WHOLE BODY WELLNESS, LLC.

<u>ARTICLE II - PURPOSE</u>

- a. To engage in the practice of chiropractic medicine as a professional medical limited liability company and to carry on services incident thereto.
- b. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this limited laibility company.
- c. The professional services of this limited liability company shall be carried out only through its members, employees and agents.
- d.
