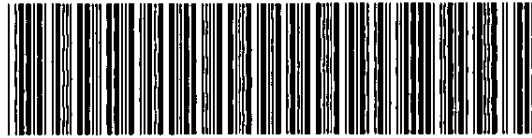

The undersigned, desiring to form a limited liability company, under the laws of the State of Florida, pursuant to Chapter 605, *Florida Statutes*, hereby subscribes to these Articles of Organization:

ARTICLE I
NAME

The name of this limited liability company (the "Company") is Education Station, LLC.

ARTICLE II
ADDRESS OF PRINCIPAL OFFICE.

DURATION

The duration of the Company shall commence effective on October 1, 2014, and shall be perpetual.

ARTICLE IV
