FIRST AMENDMENT TO ARTICLES OF ORGANIZATION
OF
CENTRA FALLS II, LLC
a Florida Limited Liability Company

This First Amendment to Articles of Organization ("First Amendment") of CENTRA FALLS II, LLC, a Florida limited liability company ("Company"), is made effective as of November 29, 2016.

RECITALS

- A. The Company was formed pursuant to Articles of Organization filed with the Secretary of State of the State of Florida effective October 9, 2014 ("Articles").
- B. The Articles of the Company were made and adopted by the Managing Member of the Company.

NOW, THEREFORE, for and in consideration of the foregoing recitals and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Company hereby agreed as follows:

1. Article 4 of the Articles is hereby deleted in its entirety and the following inserted in lieu thereof:

4. Management. The Company shall be a member managed limited liability company which shall be managed by its Managing Member. The Managing Member, as of the date hereof, is Label & Co. Pembroke II, LLC, a Florida limited liability company. Subject to limitations set forth in the Operating Agreement of the Company, the overall management and control of all aspects of the business and operation of the Company shall be vested in the Managing Member. The other Members shall have certain rights in connection with management of the Company as specifically set forth in the Operating Agreement; provided, however, no Member other than the Managing Member has the right, power or authority to sign for, act for or bind the Company.

2. In all other respects the Articles as amended by this First Amendment, remain in full force and effect. To the extent of any inconsistency between the terms of the Articles and this First Amendment, then the terms of this First Amendment shall control to the extent of such inconsistency.


