
ARTICLE VI

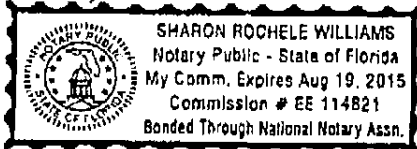


