2. Street Address of Principal Office. The street address of the principal office of the Company is 1990 Main Street, Suite 750, Sarasota, Florida 34236.

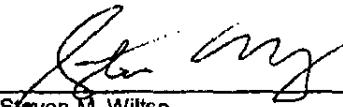

6. Amendment. These Articles of Organization may be amended in the manner provided in the Operating Agreement of the Company.

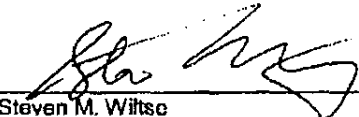
