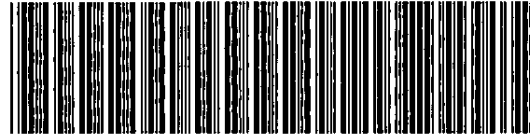





Article IV

Authorization: Under these Articles of Organization, **Ms. Victoria Lynn Sandz** and **Ms. Isabel St. Germain Singh** are authorized to represent Sassy Celeb, LLC. **Ms. Victoria Lynn Sandz** and **Ms. Isabel St. Germain Singh** will jointly represent Sassy Celeb, LLC as Chief Executive Officers, or in any capacity deemed appropriate as it relates to the legal business activities of Sassy Celeb, LLC. **Ms. Victoria Lynn Sandz** and **Ms. Isabel St. Germain Singh** jointly have the right and authority to transfer any asset or property either real or personal in accordance with their capacity as Chief Executive Officers of Sassy Celeb, LLC.

Under these Articles of Organization, no other individual is authorized to represent Sassy Celeb, LLC in any capacity as it relates to the legal business activities of Sassy Celeb, LLC. **Ms. Victoria Lynn Sandz** and **Isabel St. Germain Singh** reserve the right to jointly modify these articles as they relate to "Authorized representation" of Sassy Celeb, LLC, should they deem it appropriate in the future for a valid business purpose and in compliance with all applicable Florida statutes.

Purpose: The Purpose of Sassy Celeb, LLC shall be for: the sale of tangible goods and services under control of Sassy Celeb, LLC and for any other lawful business purpose deemed appropriate.

Article V

Management: Under these Articles of Organization, **Ms. Victoria Lynn Sandz** and **Ms. Isabel St. Germain Singh** will jointly manage all aspects of Sassy Celeb, LLC with each retaining 50% of the responsibility, decision making, work load, financial debt and profit.

Under these Articles of Organization, **Ms. Victoria Lynn Sandz** and **Ms. Isabel St. Germain Singh** will advertise the Sassy Celeb product line, joint workshops, classes, seminars, under their own LLCs, business names and trademarks until the Sassy Celeb, LLC is jointly dissolved or the Sassy Celeb product line and trademark are jointly sold. At this point each partner retains all rights to their products and services generated by their own LLC.


Article VI

Dissolution: Sassy Celeb shall be sold or dissolved with the written consent of both partners.


Article VII
