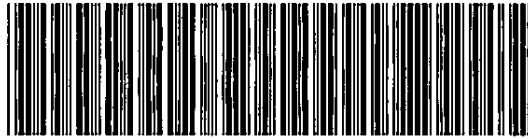



The Company shall commence its existence upon the filing of these Articles of Organization with the Florida Secretary of State.




