

## ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF

# MERIDIAN INSURANCE HOLDINGS LLC

(A Florida limited liability company)

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, Meridian Insurance Holdings LLC, a limited liability company organized and existing under the laws of the State of Florida pursuant to the Articles of Organization filed in the State of Florida on October 21, 2014, Document Number L14000163949 (the "Company"), hereby adopts the following Articles of Amendment to the Articles of Organization of the Company:

- 1. The name of the company is Meridian Insurance Holdings LLC.
- 2. That Article I of the Company's Articles of Organization, be and hereby is deleted in its entirety and replaced with the following:

### "ARTICLE I - NAME

The name of the Limited Liability Company is: Meridian Partners Holdings LLC."

The foregoing Articles of Amendment to the Articles of Organization was adopted by the unanimous written consent of the Managers and Members of the Company, the Member being the holders of that number of membership interest of the Company entitled to vote thereon and having no less than the minimum number of votes necessary to authorize or take such action, as of the 9th day of June 2015, to be effective upon a filing with the Florida Secretary of State.
