ARTICLES OF ORGANIZATION

OF

ROYAL POINT INVESTMENT PARTNERS, LLC

The undersigned, acting as the organizer of ROYAL POINT INVESTMENT PARTNERS, LLC, under the Florida Limited Liability Company Act, Chapter 605, <u>Fla. Stat.</u>, adopts the following Articles of Organization:

ARTICLE I - Name:

The name of the limited liability company is Royal Point Investment Partners, LLC (the "Company").

ARTICLE II - Address:
