**ARTICLES OF ORGANIZATION
OF
GDC PORT ORANGE, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company is **GDC Port Orange, LLC** (the "Company").

ARTICLE II -- ADDRESS

The Company shall be a member managed company. The initial Manager of the Company is Gatlin Partners 3, LLC. The Operating Agreement may contain any provision for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
