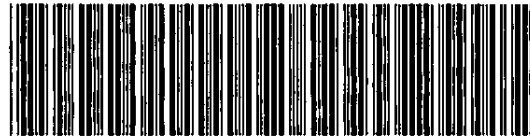

**ARTICLES OF ORGANIZATION OF**

**DURADEK SOUTHEAST, LLC**

**ARTICLE I - NAME**

**THE NAME OF THIS** Limited Liability Company shall be **DURADEK SOUTHEAST, LLC.**

**ARTICLE II - ADDRESS**

**THE MAILING ADDRESS** of the principal office of the Limited Liability Company shall be 4607 Palmetto Point Drive, Palmetto, Florida 34221.

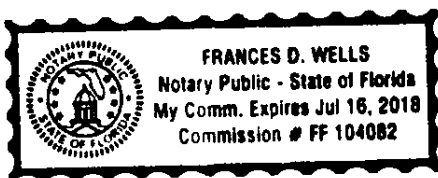
