**ARTICLES OF ORGANIZATION  
OF

The undersigned, Charles W. Rigdon, a natural person competent to contract and an authorized representative of a member of Harbor Hotels, LLC, hereby presents these Articles of Organization as the Articles of Organization of Harbor Hotels, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is Harbor Hotels, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The mailing and street address of the Company's initial principal office is 506 Harbor Boulevard, Destin, FL 32541. The Company's principal office may hereafter be at such other place or places as its member from time to time may determine.

**ARTICLE III - PURPOSE AND POWERS**


