ARTICLES OF ORGANIZATION

OF

JWF QUAD, L.L.C.

TALLAMASSEE TONIES The undersigned, under the provisions of Chapter 605 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

Article L. Name

The name of this limited liability company is JWF Quad, L.L.C. ("the Company").

Article II. Duration

Unless earlier terminated under the law or the Operating Agreement, the duration of the Company shall be perpetual.

Article III. Address of Principal Office
