The undersigned, Charles C. Sherrill, Jr., a natural person competent to contract, hereby presents these Articles of Organization as the Articles of Organization of SHERRILL & STANTON, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is SHERRILL & STANTON, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."


