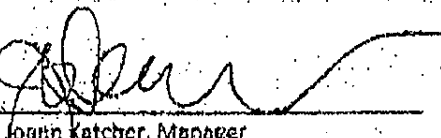
ARTICLE IV

The limited liability company shall be manager-managed. The initial managers of the limited liability company are Joann Katcher and Gary Katcher.

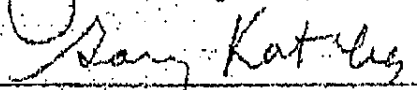
ARTICLE V

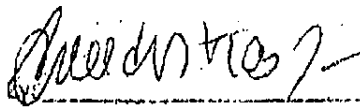
